      - (1) Forms

        - (c) Tony to bring newly-updated and -printed forms to Rounds 5 & 6
        - (d) Suggestion is to check the forms 2x/year, once in February/March, once in August/September
      - (2) Procedures

- (a) SFR to request region medical professionals identify themselves to each other so as to create a chain of command for first response.
- (b) Chief of Safety to create and establish procedure in case of medical issue.
- Street Survival Update
  - Still waiting on site confirmation in Livermore; we are likely to get the site for this purpose.
    - (1) *Note*: this site is inappropriate for autocross purposes.

  - Will run three groups, not four.
  - Might not run fun runs due to rain; will adjust as needed.
  - Sunday RGs will likely go down to 2.
